## The culture of adolescent risk-taking

An in-depth exploration of the relationship between adolescent risk-taking and peer group culture, based on extensive interviews with teens themselves, this elegantly written book shows that taking risks is a natural and necessary part of growing up. The author proposes that risks are declarations of the self, worn like badges of autonomy, or defiance, or group membership. With a broad interpretive approach locating human action within the symbolic forms, communicative practices and shared idioms of culture, Cynthia Lightfoot elucidates the cultural and psychological processes through which risk acquires meaning for teenagers and vividly depicts the drama and daring of adolescent social life.

When parents - usually mothers - try to protect their children from sexual abuse, they can be devastated to find that support from the legal system is not always there. Suspecting their husbands or partners of the abuse, mothers may seek a divorce and custody or, if already divorced, request withdrawal of visitation rights. However, if unable to prove abuse, a mother can be labeled 'hysterical' and her desperate efforts to secure her child's safety may jeopardize her case - and even result in the suspected perpetrator being granted custody of the child.

This book addresses this troubling issue and provides parents and professionals with the necessary information to protect themselves against a legal system backfire. Myers advises parents not to act too quickly, stresses the importance of documenting evidence and supplies a step-by-step strategy for attaining victory in the current United States court system. Topics discussed include psychosocial evaluations, legal options, consequences of false allegations and maintaining emotional balance.

#### Cognition and emotion From Order to Disorder Michael J. Power & Tim Dalgleish 1997, Psychology Press

The suggestion that emotions might profitably be approached from a cognitive perspective was first mooted by Aristotle in The Art of Rhetoric. However, Aristotle's ideas had little currency for almost 2,000 years, until the broad adoption of the Aristotelian approach to emotions by psychologists in the latter part of this century. Currently, the area of cognition and emotion is fertile ground for a host of interesting and provocative research programs and theoretical ideas. This burgeoning of interest was reflected by the launch of the journal entitled 'Cognition and Emotion' in 1987.

This volume is the first book, which seeks to review and integrate the various areas, which fall under the umbrella of cognition and emotion. The text has two principal aims: the first is to integrate work on normal emotions with work on the so-called emotional disorders. Within the cognition and emotion literature there are a number of influential theories of 'normal' emotions; however, these rarely address the issue of disordered emotions. Similarly, there are numerous theories which seek to explain one or more emotional disorders (e.g. Depression, Post-Traumatic Stress Disorder) bur they rarely discuss normal emotions. The present book introduces a theoretical framework, which can be applied to both normal and disordered emotions. The second aim of the forthcoming volume is to provide a core cognition and emotion textbook by including a comprehensive review of the basic literature. This aim reflects the increased emphasis on cognition in undergraduate and postgraduate courses.

The book is divided in two parts. The first part provides a broad theoretical overview of the cognition and emotion literature, with chapters on the cognitive philosophy of emotion, theories of normal emotion and theories of emotional disorder. The key points from these three review chapters are carried forward to an integrative theoretical chapter in which a framework for analyzing both normal and disordered emotions is outlined.

The second part of the book contains separate chapters on the five basic emotions of fear, sadness, anger, disgust and happiness. Each chapter provides a broad review of the relevant empirical and theoretical literature, a discussion of disordered variants of the emotion and an analysis of the normal and disordered presentations within the theoretical framework proposed in Part I.

Cognition and Emotion: From Order to Disorder should prove of interest to undergraduate and postgraduate students, clinicians and researchers alike.
